NFT PURCHASE AND OWNERSHIP TERMS (Public Offer)

2. SUBJECT OF THE AGREEMENT

2.1. The subject of this Agreement is the transfer of one or more non-fungible tokens (NFTs) owned by the Seller in exchange for a specified amount of TON coin. The exchange occurs automatically by means of a smart contract.

3. NO WARRANTIES AND LIMITATION OF LIABILITY. "AS IS"

The Buyer expressly understands, acknowledges, and agrees that the Seller may operate as a decentralized anonymous collective (DAC) or in a similar decentralized manner. The Seller may lack a formal legal personality, established juridical address, or identifiable leadership structure typically associated with traditional legal entities. The Buyer acknowledges that this structure may present significant practical and legal challenges to the enforcement of any potential claims against the Seller, its members, or contributors, and accepts this risk.

4. LICENSE TO USE

- 4.1. By purchasing the NFT Playmuse Holders Club, the Buyer acquires ownership of the token itself on the blockchain but does not acquire any intellectual property rights associated with the image.
- 4.2. The Buyer has no right to use the image represented by the NFT Playmuse Holders Club for commercial purposes.
